# Annie Jeffrey Health Fair Slated for Oct. 5

A nnie Jeffrey Health Center in Osceola has set Tuesday, October 5th as the date for this year's Health Fair. The event will be held in the 4-H pavilion at the Polk County fairgrounds from 6:45 a.m. until 12:30 p.m. The annual event is held to provide area residents with an opportunity to learn about many health, wellness, and preventive medical services provided in East-Central Nebraska. Fair-goers will also be able to take advantage of free and discounted health screening services.

Once again at the fair, Annie Jeffrey Health Center will be providing comprehensive blood screening profiles including general blood chemistry analysis, cholesterol profile, and complete blood cell count at a discounted rate of \$35 (a \$295 value). Thyroid screening (TSH), diabetes screening (Hemoglobin A1C), and prostate specific antigen (PSA) testing will also be available for \$20 per each additional test requested. It is recommended that those wishing to have their blood drawn be fasting for at least 8 hours but to drink plenty of water and to take daily medications as required. Anyone wishing to take advantage of the laboratory screening must bring a legal sized self-addressed stamped envelope so that the test results can be mailed directly to the participant.

The Polk County Health Department will be offering seasonal flu shots for \$25 or free with a Medicare Card. Four Corners Health Department will be on hand with their skin scope providing free evaluations of cancer causing sun damage. Free blood pressure checks, pulse oximetry screening, and blood typing will be available at the event.

Aging Partners of Lincoln will be on hand from 8:00 am to 12:30 pm with the Sahara ultrasound bone densitometer to test bone density in an individual's heel. This is a noninvasive procedure that easily interprets results in less than 5 minutes. This service is being offered free to individuals of all ages in order to assist in the screening of osteoporosis or thinning of the bones.

This year's health fair promises to be a health care oriented event with a variety of professionals on hand to answer questions and demonstrate their services. Available for the public to tour will be the Star Care Air Ambulance helicopter from Lincoln and the Midwest Medical Husker helicopter from Columbus, weather permitting. There will be a dietician available to evaluate nutritional intake and assist with determining an individual's body fat.

The Aging Partners Office will be providing information about Medicare and Medicare Part D open enrollment. Area nursing homes, assisted living, skilled care, hospice care, respite care and home health agencies will be represented at the fair to answer questions about elderly and dependent care. They will be presenting care options for individuals faced with decisions about care for a parent or grandparent who is unable to care for him or herself. Professionals will be available to answer questions about sleep disorders, living wills, advance directives. domestic violence, injurv prevention, and sensible weight loss.

People attending the fair will be given the opportunity to help the local Blue Valley Community Action food pantry by donating money, canned goods and non-perishable food items. With the winter months approaching, area food supplies deplete quickly; the food drive will assist in restocking the supply for the upcoming winter months. The Annie Jeffrey Volunteers will be sponsoring a bake sale the morning of the fair. Annie Jeffrey Memorial County Health Center cookbooks will be available to purchase for \$8.00 each.

We encourage you to browse through the exhibits, register for door prize drawings, and enjoy the complimentary continental breakfast. Stop by before work, or anytime throughout the morning.

## Foundation for Annie Jeffrey ANNUAL REPORT

For our Fiscal year: July 1, 2009 through June 30, 2010

he Foundation for Annie Jeffrey is a non-profit corporation organized to provide funding for projects (such as new medical equipment or facility renovations) that promote health care in the communities served by Annie Jeffrey Health Center. The Foundation is governed by an eight-person volunteer board. The hospital foundation keeps track of funds which are donated and for what purpose they are donated; seeks grants and other outside funding; provides tax reports to the IRS; recognizes donors in newsletters and on our Wall of Commitment; helps publish quarterly newsletters; plans fund raising events; and participates in numerous hospital and clinic activities. Donations to the foundation qualify as tax-deductible charitable gifts.

# Here is a recap of the past years events and activities.

In September, the Foundation for Annie Jeffrey kicked off its annual campaign. Annie Jeffrey Health Center needed funding for numerous Wish List items. Our campaign raised almost \$70,000.00 to help fund Phase II of the building project and purchase a new anesthesia machine, EKG machine and a new stress testing treadmill. The Foundation also purchased a new treadmill for the wellness center and helped purchase a new Birthing Warmer for our obstetrical department with help from the Annie Jeffrey Volunteers.

- An anesthesia machine is used to support the administration of anesthesia.
- An electrocardiogram abbreviated as EKG — is a test that measures the electrical activity of the heartbeat.
- Cardiac stress testing treadmills are used for conducting exercises that may produce signs and symptoms of heart disease when exposing the heart to the stress of exercise.

The annual Foundation Family Tree Celebration was held on the first Sunday in December and raised \$1,000 to help fund new equipment. This event allows community members to purchase ornaments to hang on a Christmas tree at Annie Jeffrey Health Center to remember and honor loved ones. All names on the ornaments were read during the ceremony.

In May, the Phase II remodeling project at Annie Jeffrey Health Center began. The three areas that were updated were the Business Office, Medical Records, and the Annie Jeffrey Family Medicine clinic. Local contractors and the maintenance crew of Annie Jeffrey renovated those three areas of the facility by painting, wiring, and installing new flooring and carpeting, shelves, and an upgraded ventilation system in the Business Office and Medical Records area. The Business Office is now connected to the Medical Records file room.

The health center's medical clinic, Annie Jeffrey Family Medicine, made big changes to better serve its patients. The original hospital nurses station was removed to make room for new clinic exam rooms. With the addition of our new physician, Dr. Cameron Sidak, increased space was needed to take care of more patients. The clinic expansion also included adding a new office, lab area, new flooring and an expanded waiting area.

In June, golfers from area hospitals and local businesses participated in the second annual Foundation for Annie Jeffrey golf tournament at Ryan Hills Country Club. Proceeds from this event were used to purchase a new Cautery Unit for Surgery at Annie Jeffrey Health Center.
