The screenings will include waist circumference, weight, height, body fat, BMI, and Blood Pressure. Free total cholesterol levels and discounted rates on other Health Fair lab will be available at the Spring Health Fair for those who submit all 8 activity logs on time.

Preventing Falls

A simple fall can change your life. Each year there are thousands of older men and women who fall and break a bone. Getting older can bring lots of changes. Your sight, hearing, muscle strength, coordination and reflexes aren't what they used to be. Some medicines can cause dizziness.

Falls and accidents seldom just happen. There are things you can do to take care of your overall health so you will lower your chance of falling. Here are a few of them:

- Ask your doctor about a bone density test this will tell you how strong your bones are. Annie Jeffrey Health Center can provide a bone density scan for you here in Polk County. After discussing the test results with your doctor, plan an exercise program that is right for you. Regular exercise helps keep you strong, improves your muscle tone, and keeps you flexible.
- Have your vision and hearing tested often.
- Find out the possible side effects of medicines you take. Some medicines affect your balance.
- · Limit the alcohol you drink.
- Always stand up slowly after eating, lying down or resting. Getting up too quickly can cause your blood pressure to drop, which can make you feel faint.
- Use a cane or walker to help you feel steadier when you walk. Be very careful when walking on wet or icy surfaces.

- Wear rubber-soled, low-heeled shoes that fully support your feet.
- Hold handrails when you use the stairs.
- Don't take chances. Don't stand on a chair to reach something that is too high – use a 'reach stick' instead.

You can help prevent falls by making changes to unsafe areas in your home. In stairways and hallways: make sure there is good lighting with light switches at the top and bottom of the stairs, keep areas where you walk tidy and make sure all carpets are secure, have handrails on both sides of all stairs and make sure they are securely fastened. In bathrooms: mount grab bars near toilets and on both the inside and outside of your tub and shower, place non-skid mats or carpets on all surfaces that may get wet, and keep a night light on. In your bedroom: put night-lights and light switches close to your bed and keep your telephone near your bed. In other living areas: keep electrical cords and telephone wires near the walls and away from walking paths, tack down all carpets and area rugs firmly to the floor, arrange your furniture and other objects so they are not in your way when you walk, make sure your sofa and chairs are a good height for you to get into and out of them easily.

Trauma Recertification

he Nebraska Department of Health and Human Services announces the re- designation of Annie Jeffrey Memorial County Health Center as a Level IV Trauma Center.

Annie Jeffrey Health Center once again met the standards of the State of Nebraska for designation as a Level IV Trauma Center without any deficiencies. The accreditation is based on recommendations by a survey team of health professionals utilizing standardized established criteria for trauma centers. Annie Jeffrey became accredited first in 2008, this accreditation survey takes place approximately every four years.

A survey team evaluated the administration, emergency department, clinical

laboratory, patient transfer agreements, pre-hospital services, quality improvement programs, and radiology services. Additionally, the survey team looked for the hospital's commitment to community outreach, particularly for prevention. In addition, all medical providers and acute care registered nurses at Annie Jeffrey Health Center have advanced certification in trauma life support.

Involvement by hospitals in the Trauma Care System is on a voluntary basis. As part of the statewide network of trauma care centers, hospitals may accept, stabilize and care for trauma patients with significant injuries.

Under Nebraska law, hospitals can seek designation as a Level I, II, III or IV trauma center, with Level I requiring the most resources. The designations set specific criteria and standards of care that guide hospital and emergency personnel in determining the level of care a trauma victim needs, and whether that hospital has the resources to care for the patient, or whether the patient should be transferred to a trauma center more appropriate for the patient's injuries.

Transfer agreements must be in place with Level I and II Trauma Centers for patients that exceed the Level IV Trauma Center's resources.

"The certification process has required us to work closely with the county EMS units. I can't say enough good things about the EMTs in the county! Polk County is extremely blessed to have such a dedicated group of people who give excellent care, sacrifice time away from their jobs and family, and take significant risks to care for the citizens of the County.", commented Dr. Jameson, Trauma Director at Annie Jeffrey Health Center

Annie Jeffrey Health Fair

he sixteenth annual Annie Jeffrey Memorial County Fall Health Fair held on October 1st was a huge success. Over 160 fairgoers, from a variety of Nebraska communities visited the health exhibits with several taking advantage of the discounted comprehensive health blood profiles. Ten anatomy students from a local school took advantage of the educational opportunities available through the health fair. A continental breakfast was provided by Annie Jeffrey's dietary staff. The Annie Jeffrey Volunteers held a bake sale raising money to donate back to the Annie Jeffrey Memorial County Health Center.

The health fair is designed to be an event where people can learn about their own health and obtain information about services provided in the area. The fair provided several interactive and educational opportunities for those who visited. Vendors provided free services: blood typing, body fat analysis, blood pressure screening, and skin analysis for sun damage were some of the services available. Annie Jeffrey's pharmacist was available to review people's medications and answer fairgoers questions. Over 60 adults received their seasonal flu vaccination from the Polk County Health Department.

There were 20 vendors at the fair providing health information and services. This year new to the fair was the York General Dialysis Center. Twenty individuals took advantage of the free Bryan Health Heart Aware

grows as the weather turns colder, and the use of furnaces, fireplaces, car engines and generators in poorly ventilated areas can lead to carbon monoxide exposure.

Carbon monoxide is a colorless, tasteless and odorless gas that can affect the flow of oxygen in the blood stream. Poisoning can take hours to days. Signs include headache, dizziness and flu-like symptoms. Those who are exposed need to go to their health care provider or hospital to receive immediate treatment.

Am I at Risk for Sleep Apnea?

Sleep apnea can affect anyone at any age, even children.

Risk Factors for Sleep Apnea include:

- Being male
- Being overweight
- Being over age 40
- · Having a large neck size (17 inches or greater in men and 16 inches or greater in women)
- · Having large tonsils, a large tongue, or a small jaw bone
- Having a family history of sleep apnea
- Gastroesophageal reflux, or GERD
- Nasal obstruction due to a deviated septum, allergies, or sinus problems

If you or someone you know has any of the above risk factors, make an appointment to see your physician and discuss your treatment options. If your provider refers you for a sleep study, you will enjoy having it done locally in our new and updated sleep rooms here at Annie Jeffrey Memorial County Health Center.



Annie Jeffrey Memorial County Health Center Annual Report 2019

Annie Jeffrey Memorial County Health Center, following its eighteenth full year of operation as a critical access hospital, continues to grow. The facility continues to have steady utilization. This report summarizes some of the activity and accomplishments of fiscal year 2019.

The list of basic services provided by the Health Center remains unchanged. Emergency Department, Radiology and Laboratory coverage is maintained around the clock. Registered nurses staff the facility 24 hours per day without regard to census.

Thorough medical record reviews continue to be conducted by a variety of individuals, far exceeding the basic CoP requirements. The Utilization RN continues to review nearly 90% of all open records. Changes in the delivery of care are made when appropriate as a result of close examination of medications, treatments, physician orders and general care. The RN nurse reviews all closed records for accuracy and assesses any missed charges. Medical records personnel examine all records following dismissal, utilizing a specific check list. Each department of the facility, including all outpatient services and clinics are involved in Quality Assurance activity. Medical Staff review is comprehensive including outpatient clinics, Swing Beds, inpatient and outpatient surgery in addition to Med/Surgical, ER, OB and all transfers. Outliers go through QA Committee and are referred to the Medical Staff as necessary, and for external review when appropriate.

AJMCHC continues to participate in the quarterly patient satisfaction survey which provides patient and family review of care and service. Results and comments are shared with staff. All Hazards Plan and Pandemic Flu policies have been developed. The Health Care Policy Review Committee continues to meet quarterly to review all patient care policies and practices.

Facility, Equipment and Services:

- Level IV Trauma Certification;
- Working with UNMC to implement a teledermatology clinic in the fourth quarter of 2019;
- Utilizing a transfer service with BryanLGH West for trauma;
- Conducted four successful blood drives in conjunction with the Nebraska Community Blood Bank;
- The Foundation for Annie Jeffrey and Annie Jeffrey Volunteers continue to be a conduit for financial support for the facility;
- Completed renovation and upgrading of our sleep study lab;
- Added a new cardiologist and cardiology clinic to our outpatient clinics;

- AJMCHC updated and added service areas to its webpage and Facebook page to increase accessibility to information for its patients;
- Utilizing telehealth equipment for eEmergency and ePharmacy services;
- Began utilizing an adenosine triphosphate (ATP) monitor for infection control and QA;
- Provided space to the Center for Survivors on a weekly basis:
- Provided space for a local chapter of Weight Watchers weekly;
- Hosted students from area schools to educate them on health related careers;
- Upgraded and installed our medication dispensing unit and accompanying software;
- Added new spin cycles to our wellness center;
- Welcomed a new physician to our medical staff;
- Hosted 2 health fairs in the county;
- Purchased and installed a new DEXA scanner unit;
- Updated and installed a new EMR (Centriq) including enhanced functionality;
- Purchased and installed a new 3D mammography system;
- Purchased and put into use a second new Game Ready system and High-Low Mat table in Physical Therapy;
- Added a third tech to our laboratory.

Acute Care: There were 104 acute admissions during 2019 compared with 122 during the previous year. Average length of stay was 2.31 days which was nearly the same as last year. There were 40 newborn days, compared to 31 in the previous year.

Swing Bed: Swing Bed days were 151 compared to 167 last year.

Surgical Procedures: Surgical procedures were 55, compared to 48 last year.

Outpatient Services: Observation hours were 2,837 compared to 2,662 last year. CT scans decreased to 325 from 353 last year. Emergency room visits were 1,145 compared to 1,407 last year. Radiology visits were 903 compared to 1,113 previously. Specialty clinic visits were 670, down from 792 last year. Physical Therapy modalities decreased to 9,913 from 9,954.

The Critical Access Hospital designation of Annie Jeffrey Memorial County Health Center has allowed the facility to continue to make progress toward expanding and improving services. We anticipate continuing to renovate and upgrade our medical center as is fiscally feasible. We are currently reviewing and updating our Strategic Plan and anticipate beginning the next phase implementation during FY 2019.

Representatives from LMC Insurance presented the 2019 NHA Services/LMC Safety Awards on October 16, 2019 to NHA member hospitals who performed at the highest levels when it comes to employee safety in their facilities.

Awards are based on these criteria:

- Loss data compiled through the last completed workers compensation policy period
- · Participation in an NHA/LMC sponsored safety seminar
- Performance of strain and fall prevention programs through the last completed workers compensation policy period
- Safety Performance 12-month loss ratio of 0%
- Safety Performance Experience mod of .85 or under
- No reported fall injuries for the policy period
- No reported lifting/strain injuries for the policy period

There was only one silver award winner and six bronze award winners in the state. Receiving a Bronze award was Annie Jeffrey Memorial County Health Center, Osceola.

screening opportunity completed by Bryan Health nurses in an attempt to prevent and make an early detection of heart disease. Approximately 6 other entities were unable to attend this year's fair but had information on hand for participants to take home.

Returning to the health fair this year was the Department of Health and Human Services Water Well Standards Office. They provided free well water testing for nitrate levels and had a water supply specialist on hand to interpret the screening results and answer questions. Sources of nitrates in groundwater include fertilizers, animal waste, and human waste. Nitrates are colorless, odorless, and tasteless which make it undetectable without laboratory testing. The quality of water from private wells in Nebraska is not regulated by

federal or state mandates. Since many contaminants can present a health risk to human and livestock if present in sufficient concentrations annual water testing is recommended. Twelve individuals took advantage of this free service. Five of the twelve water samples tested high for nitrate levels and were able to receive additional testing information. Twenty-four additional individuals forgot their water samples but were able to receive education and take home water well test strips.

The Health Fair Committee would like to thank all of the exhibitors, participants, and Annie Jeffrey staff helping at the fair for making the 2019 health fair a success. Planning has already begun for the 17th annual Fall Health Fair. Look for upcoming information on the 13th annual Mini-Spring Health Fair.
